**Whereas** the Owner has reviewed and concurs with the purposes, the objectives, and the Procedural Rules of the Rapid Site Access Program (RSAP),

Now therefore the Owner agrees with the RSAP Administrative Committee to be bound by the following:

- a) The Owner supports the implementation of the Rapid Site Access Program ("RSAP") for the purposes and objectives articulated therein,
- **b)** The Owner agrees to be bound by and comply with the *RSAP Procedural Rules*, as amended from time to time, and;
- c) The Owner agrees Active RSAP Participants shall be exempted from the requirement to submit to a site access test as a pre-requisite to qualifying for site access, and the site access policies of the Owner will be amended accordingly.

It is understood by the parties hereto that no bargaining relationship is created by the Owner with any RSAP Participant Union. Similarly, where the Owner has participated in any way in the processes and administrative matters contemplated in the RSAP Procedural Rules, it is only for the purposes of this document and the enhancement of RSAP and in no way can be construed to be creating a bargaining relationship, extending a voluntary recognition or taking actions which, by action of law, would bind the Owner to any Collective Agreement with any RSAP Participant Union, the Building Trade of Alberta, or any of their affiliates.

Where the Owner is mentioned in this document or any other RSAP document, the term shall be taken to mean the person or persons designated by the Owner in respect to participation in the administration of portions of RSAP, wherever that context is appropriate.

It is further understood that this agreement may be withdrawn by the Owner, with or without reasons, on ninety (90) days notice to the RSAP Administrative Committee. Through the course of implementing said notice, RSAP Participants presently on the Owner's site shall be grandfathered such that they will continue to qualify for access to the site without the requirement of submitting to a site access test for the duration of their continuous employment on site.
