## **Boilermakers Lodge 146 Training Course Reimbursement Policy**

Guidelines for Members Applying for Course Reimbursement

Revised 11/01/19



The Boilermakers Lodge 146 Training Trust Fund offers reimbursement upon successful completion of many trade related courses. A list of approved courses is available at <a href="https://www.boilermakers.ca">www.boilermakers.ca</a> - "Members Only" section. If the course is approved, follow the steps outlined below to apply for pre-approval for reimbursement.

- 1. A **Pre-Authorization for Reimbursement Application** must be submitted to 146safetytraining@boilermakes.ca, in person or via mail <u>PRIOR</u> to course start date.
- 2. Applicant must be a member in good standing with the Boilermakers Lodge 146 for a minimum of one year and must have worked through Lodge 146 in the last 12 months to qualify. The Boilermakers Lodge 146 Training Trust Fund must be receiving employer contributions on the applicant's behalf.
- 3. The course(s) <u>MUST BE</u> listed on the **Courses Approved for Reimbursement** list. (Available at www.boilermakers.ca "Members Only" section.)
- 4. Refund amount and eligibility will be reviewed on a case by case basis. Refunds will be issued in full or in part as determined by the Education Training Trust Fund at time of pre-approval. Please allow 5 to 10 business days for review of the **Pre-Authorization for Reimbursement Application**. If a response is not received within 10 business days please contact 780-451-5992.
- 5. Refunds will only be issued upon receipt of the following:
  - a) Copy of tuition/course receipt from course provider.
  - b) Copy of certification or final marks. Applicant must successfully complete the course with a passing grade.
  - c) Any additional documentation as may be requested at time of pre-approval.
  - d) Copy of the Pre-Approval letter. The Pre-Approval letter is valid for 12 months. If the approved course is not completed within 12 months applicant must re-apply.
- 6. ABSA Initial B Pressure exam fee reimbursements <u>DO NOT</u> require pre-approval; however, a copy of the original ABSA receipt and a copy of ABSA Initial Pressure ticket must be submitted to lhoward@boilermakers.ca within 6 months from the ABSA exam date. Only members who obtain an ABSA Initial Pressure ticket will be reimbursed.
