 - h. Not contain any viruses, worms, or other interfering computer programming; and,
 - i. The Boilermakers Lodge 146 reserves the right to not enter any person sending any of the above-mentioned content.

Eligibility

One (1) **Early Bird Winner** shall be selected as follows:
